PRESIDIO'S REPORT
March-April, 1974, term

Brief summaries of certain meetings:

After the October 20, 1973 City-Wide STAR TREK Meeting, a group of about four STAR TREK fans started meeting November 29 on the first, third, and last Thursdays of every month at the Bennett Martin Library auditorium to discuss the creation of a local STAR TREK club.

January 31, 1974 -- The subjects of establishing a local business company dealing in legal STAR TREK material and a University of Nebraska STAR TREK club -- both with Star Base Andromeda as the parent organization -- were brought up, but both subjects were later shelved until more interest could be generated. The precedent of holding a STAR TREK Slide Show every meeting was started.

February 7, 1974 -- The Lincoln, Nebraska City-Wide STAR TREK Club: Star Base Andromeda was formally created with the signing of the Conceptual Constitution by the four Charter Members, Richard Heim, Nancy Munden, Marvin Reidel, and David Robinson.

February 21 -- Various topics were brought up, including: S.T.A.R. and S.T.F.U affiliation; homemade STAR TREK games to be

played at meetings; club symbol; the Second City-Wide STAR TREK Meeting; club rubber stamp; and club publications. These topics were introduced at this meeting to be discussed in detail at later meetings.

By March, meetings were being held every Thursday evening at the Bennett Martin Public Library auditorium.

March 28 -- The first issue of the club newsletter, which was tentatively named, "Dynastar", was published. It was decided that the permanent name for the club newsletter will be "Andromedan Log" and that the name of the club magazine will be "The Kelvan Outpost".

April 4 -- A photographer from the Lincoln Journal newspaper visited the meeting to take a photograph as part of an article to be written by Linda Ulrich of the Journal for publication in the Lincoln daily newspaper. The article would be about the STAR TREK activities and clubs in Lincoln. An April 6 interview for the article was agreed upon

April 11 -- No meeting was held since three members (Agris Taurins, David Robinson, and Richard Heim) attended EQUICON 74, a STAR TREK convention in Los Angeles, California.

April 18 -- It was reported that at EQUICON: GenerRoddenberry had announced that Paramount Studios is interested in filming a STAR TREK movie for theatrical release and is interested in bringing STAR TREK back to network television as a live-action series, there are a lot of hurdles yet, but the first steps have been taken; the STAR TREK Animated Series has been renewed by NBC; and Dorothy C. Fontana has written the novelization of "The Questor Tapes".

April 25 -- Star Base Andromeda became an Official Chapter of the STAR TREK Association for Revival.

GENERAL MANAGER'S REPORT

The City-Wide Star Trek Club: Star Base Andromeda is affiliated with two national Star Trek clubs: the Quei-Starmerian Network (Q.S.N.) and the Star Trek Association for Revival (S.T.A.R.).

Star Base Andromeda serves as the local Star Trek and Gene Roddenberry portion of Q.S.N.; however Q.S.N. and Star Base Andromeda serve as two distinct organs of the same organization, each maintains administrative and executive independence from the other.

Star Base Andromeda is also an authorized chapter of S.T.A.R., which operates on a national level to help bring Star Trek back, either as a full-length movie or as a live-actor network television series. At this time, S.T.A.R. is the largest Star Trek fan club in the world.

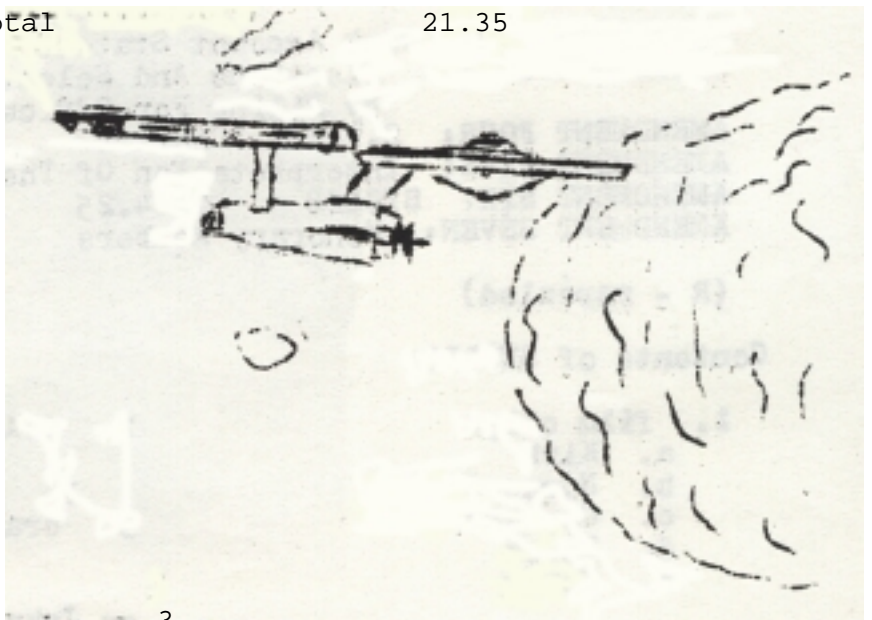
